- (a) To provide for the maintenance, repair and restoration of monuments, headstones and grave markers of historical or architectural significance to the community, thus promoting an appreciation of community history to the educational benefit of the general public.
- (b) To provide funds for the preservation, beautification and maintenance of abandoned or deteriorating graves of deceased persons and cemeteries generally, focusing on areas open to the public or to the public's view and for the care and replacement of trees, flowers, shrubbery and lawns, including removal and replacement of diseased trees, thereby contributing to the aesthetic enjoyment of the community and combating deterioration.
- (c) To provide for the maintenance of semipublic areas whose maintenance would otherwise devolve upon government, thereby lessening the burdens of the government.

Your donation to the Akron Community Cemetery Preservation Fund established with the Akron Community Foundation may be eligible for income, estate, and gift tax charitable deductions in accordance with Federal and/or State laws.
